### Looking For a Last Minute Tax Credit?

Home Builders Care is listed on the charitable tax credit list for the State of Arizona. This tax credit is for persons who help those on welfare or the working poor. Detailed information about the credit can be obtained by visiting the following link:

Essentially taxpayers filing as single and unmarried head of household have a maximum credit amount of \$200. Taxpayers that are filing as married/joint have a maximum credit of \$400. Taxpayers filing married/separate have a maximum credit of \$200.

Please note the charitable tax credit is in addition to the tuition tax credit, meaning taxpayers can receive credits for both.

# TAX CREDIT! PLEASE FORWARD!



Reminder: **Donate up to \$200, or \$400 as a married couple to Home Builders Care** as a charitable tax credit. This is **in addition to the school tax credit!**

Thanks to the Arizona charitable tax credit law, ARS 431088, state taxpayers now have more incentive to make cash donations to **Qualified Charitable Organizations** that help the working poor. Contributions up to \$200 for single contributors and \$400 for married couples earn a dollar-for-dollar tax credit on Arizona income tax.

The amount of the tax credit is equal to any increase over the amount you gave in 1996, or later if you did not itemize in 1996. For example, if you itemized contributions of \$200 in 1996, and increase your contributions this year to \$400, you would be eligible for the state tax credit.

**Please make your personal check payable to *Home Builders Care* and make sure it is dated no later than Dec. 31, 2009.**
